## Leasehold information for apartments at Burgoyne Square

The length of term of the lease and the initial annual ground rent is outlined below and will be explained to you by our sales executive on site. - Apartments at this development are being sold on a leasehold basis.
- The length of term of the lease for this apartment is 125 years commencing on 01/01/2022 and the initial ground rent is £0 (peppercorn).

### Ownership of the Freehold for apartment blocks

In common with most developers, it is not Taylor Wimpey's policy to retain the ownership of the freehold title to your property indefinitely. Therefore, it is likely that an agreement has been or will be entered into by Taylor Wimpey with a third party for the sale of the freehold reversion of the leasehold apartments and associated communal areas on the Development once the last Property has been sold.
